Chhatarpur: A viral video featuring Bageshwar Dham’s spiritual head, Pandit Dhirendra Shastri, has ignited a storm on social media, drawing national attention to his bold claims related to India’s security. In the video, Shastri asserts that he possesses divine insight into future events and urges the Indian government to use his abilities for the nation’s benefit.

Addressing Defence Minister Rajnath Singh directly, Shastri said, “I may not hold any official position, but with the divine grace of Lord Hanuman, I have a consciousness that can be of



service to the nation. My powers should be used confidentially to foresee and prevent future incidents in the interest of India.”

He added a dramatic note of caution: “If I speak openly, they might target me. That’s why such information must remain confidential.” Shastri emphasized that merely delivering speeches like Mann Ki Baat won’t help the country—action rooted in spiritual foresight is needed.

The video, widely circulated across social media platforms, has sparked intense debate over the intersection of faith, mysticism, and national security, with many questioning the implications of spiritual figures stepping into such sensitive domains.

Morena: Tension surfaced in Khajuri village’s Sanjay Nagar area of Ambah, Morena, after miscreants vandalized a statue of Mahatma Gandhi. According to local residents, the statue was deliberately toppled, causing damage to one side. Upon learning of the incident, local Congress MLA Devendra Sakthar immediately informed the police. Villagers had alerted him after discovering the statue had been desecrated during the night.

Ambah police station in-charge Satendra Kushwah confirmed the act of vandalism, stating, “The statue appears to have been pushed down during



the night. We are actively investigating the incident and speaking with locals to identify those responsible.”

The incident has sparked concern in the community, with residents calling for swift action against those who disrespected the memory of the Father of the Nation. Police presence has been increased in the area as the investigation continues. This act of vandalism has not only damaged property but also hurt local sentiments, triggering calls for enhanced security around public monuments in the region.

Use of Jeevamrut ends Abhay Singh’s

dependence on chemical fertilizers

Cheetah ‘Nirva’ gives birth to five

cubs in Kuno National Park



Sehore: In a bid to combat declining soil fertility from the persistent use of chemical fertilizers and pesticides, the government is actively promoting the adoption of Jeevamrut among farmers. This initiative, supported by the Agriculture Department, aims to revitalize agricultural land and enhance crop yields.

Jeevamrut is a natural organic

fertilizer made from easily accessible ingredients: cow dung, cow urine, jaggery, gram flour, a bit of soil, and water. Farmers create this solution by mixing the ingredients and allowing it to ferment for a few days before applying it to their crops, either at the roots or as a foliar spray. This organic fertilizer enriches the soil with essential nutrients and beneficial bacteria, fos-

tering improved fertility.

The Agriculture Department provides comprehensive support for farmers interested in Jeevamrut, including training, financial assistance, and grants through the National Food Security Mission. Agricultural scientists also conduct field experiments to demonstrate the benefits of Jeevamrut in enhancing crop quality.

Abhay Singh, a farmer from Salkhedha village, has experienced significant benefits from using Jeevamrut. Previously reliant on chemical fertilizers, he noticed a decline in soil fertility and crop quality, leading to increased costs and reduced income.

After learning about Jeevamrut and receiving training from the Agriculture Department, Singh established a Jeevamrut unit on his farm. He now regularly applies it to his crops, resulting in improved soil quality and increased production. Singh is now inspiring fellow farmers to embrace this sustainable practice.

Joy in the wild

Sheopur: In a heartening development for wildlife conservation, Kuno National Park has welcomed a new litter of cheetah cubs. Five-year-old female cheetah Nirva has given birth to five healthy cubs, bringing fresh hope to India’s ambitious cheetah reintroduction program. With this, the total number of cheetahs in Madhya Pradesh has risen to 31.

The news was officially confirmed late last night by Kuno park authorities, sparking celebrations among conservationists and wildlife enthusiasts.

Chief Minister Dr. Mohan Yadav shared the update on X (formerly Twitter), congratulating the Kuno team for their dedication. “This is a proud moment for India’s biodiversity conservation efforts,” he said, calling it a significant step forward under Prime Minister Narendra Modi’s vision for nature preservation.



Union Environment Minister Bhupender Yadav also shared the news on X, applauding the continued success of the cheetah project. Recently, two cheetahs from Kuno were relocated to Gandhi Sagar Sanctuary in Mandsaur, temporarily bringing the park’s cheetah

count down to 24. With the birth of Nirva’s five cubs, the population has now climbed to 29.

The arrival of the cubs is a strong sign of adaptation and progress, reaffirming hopes for a thriving cheetah population in India’s wild landscapes.

4-Year-Old Girl Victimized at Wedding Ceremony

Jabalpur: In a shocking incident a 4-year-old girl who attended a wedding ceremony fell victim to a heinous act.

The incident occurred in the Majhgawan police station area, where the girl was sent by her mother with great care and love. Unfortunately, the accused was among the guests. After a while, the girl went missing, prompting her family to search for her.

After a lengthy search, the girl was found crying, and her family was horrified to discover blood stains on her clothes. They imme-



diately reported the incident to the police, leading to the registration of a case against an unknown

assailant under the charges of rape, kidnapping, and the POC SO Act. Authorities have detained several suspects and are currently conducting interrogations.

Additional SP Suryakant Sharma stated that the crime against this innocent child is being taken very seriously. A dedicated team, including female officers, is working tirelessly on the case. Some suspects have been identified, and several leads have emerged, with the police confident that the perpetrator will be apprehended soon.

23-year-old hangs self after

sharing heartfelt video



Ujjain: A heartbreaking incident of love betrayal and subsequent suicide has emerged from the district. A 23-year-old youth, Sarvesh Raikwar, took his own life after expressing his emotional turmoil in a video. In the video, he revealed the pain of being betrayed in love. The tragic event occurred in Chhoti Mayapuri, within the jurisdiction of the Chimanganj police station. Sarvesh used a sari to make a noose and hanged him-

self from a ceiling fan in his home.

Sarvesh had reportedly fallen in love with a girl from Delhi. In his video, he made serious allegations against the girl’s brother and mother, indicating a deep-seated conflict. Upon discovering the incident, his family called for neighbors’ assistance and hurriedly brought him down before informing the police. Unfortunately, despite being rushed to the district hospital, doctors pronounced him dead upon arrival.

Gwalior: Parents often hope that their children will support them in their old age, but a troubling incident has emerged from Gwalior where a son physically assaulted his mother. The entire incident was recorded by a nearby CCTV camera.

This incident took place in New Shanti Nagar, within the jurisdiction of the Janakganj police station. In the video, a woman can be seen standing on the road, conversing with a man seated on a chair. Suddenly, her son arrives and begins to beat her. The situation escalates as the son violently strangles his mother. Upon receiving information about the incident, the Janakganj police arrived at the scene to manage the situation and assured that action would be taken. However, it has not yet been confirmed whether a formal complaint (FIR) has been registered in this case.
