In a powerful statement underscoring India's measured response to terrorism, Congress MP Shashi Tharoor, while strongly defending 'Operation Sindoor' emphasised that the mission was a "necessary and precisely targeted and "not a cáll for war".

The All-Party Delegation led by Shashi Tharoor reached Panama to convey India's strong message of zero-tolerance against terrorism.

Citing the harrowing plight of 26 women whose "Sindoor" (vermilion) was wiped off from their foreheads by terrorists, Tharoor said, "India's



response was carefully, precisely and calibrated strikes on terror bases avoiding civilian, military, or government targets entirely".

He said, "These terrorists came and wiped the Sindoor off their foreheads. Infact there were some women who cried and asked the terrorists "kill me too" and they said No! Go back and tell what happened to

Drawing an emotional parallel between the colour of "Sindoor" and the blood of the terrorists, Tharoor said, "we heard that cry and India decided that the colour of the Sinforehead of our women also match the colour of the blood of the killers, the perpetrators, the attackers".

Emphasising India's commitment to restraint, Tharoor said, "India is not a war-mongrel state. Even when we conducted those attacks on nine terror bases, our government said very clearly, without any doubt we are not looking for any escalation."

He highlighted that no Pakistani military, government, or civilian targets were struck. These were carefully, precisely, calibrated strikes. We hit only terror bases.

Azad, part of all party delegation, hospitalised in Kuwait

DMK announces Rajya Sabha candidates

The ruling DMK on Wednesday announced its candidates for the June 19 biennial elections to the Rajya Sabha from Tamil Nadu to fll up six seats, by allotting one seat to its ally actor-politician and Makkal Needhi Maiam (MNM) Founder Kamal Haasan who is all set to enter Parliament for the first time.

The DMK, which could win easily four seats in the 234-member Assembly, will contest three seats.

The Opposition AIADMK, with 66 members (including four from the rebel camp of ousted leader O Pan-

neerselvam), could win two seats, with the support of its ally, the BJP, which has four MLAs.

Going by its strength, the DMK could easly win four seats—three on its own and another one with the support of its allies. DMK's strength in the assembly is 133, its allies, Congress has 17 MLAs, Viduthalai Chiruthaigal Katchi of Thol Thirumavalavan (4), CPI and CPI(M) two each, besides other partners, including MDMK, more than what is required.

Tamil Nadu Chief Minister and DMK President M K Stalin in a statement here said Kamal's party was al-

lotted one RS seat as per the poll pact agreed upon during the 2024 Lok Sabha polls, while deciding to contest the other seats.

Soon after the announcement, the MNM leaders met and adopted resolution announcing Kamal as the party's candidate for the seat and the actorpolitician is all set to enter the Parliament for the first time. Apart from renominating senior Counsel P Wilson for a second successive term, Mr Stalin announced DMK Salem district secretary S. R. Sivalingam, party functionary and noted Tamil writer and poet Salma as its other candidates.

The Congress party, under the leadership of Maharashtra Pradesh Congress Committee (MPCC) president Harshavardhan Sapkal, took out the Jai Jawan, Jai Kisan, Jai Hind rally here on Wednesday to honour the bravery of Indian armed forces during Operation Sindoor.

The rally saw participation from state vice president Mohan Joshi, MP Prof Ravindra Chavan, MP Dr Shivaji Kalge, District Congress president Hanumant Patil Betmogrekar, City Congress president Abdul Sattar

Speaking on the occasion, Sapkal

said terrorists entered 300 km inside Indian territory at Pahalgam in Jammu and Kashmir, killed 26 innocent civilians and escaped—this is a failure of the government, he charged.
"How did these terrorists manage

to get in so deep and then escape?'

he questioned.

He further asked "Why did the
BJP government miss the opportunity to take control of Pakistan-occupied Kashmir (PoK) and instead declare a sudden ceasefire? Was the ceasefire declared due to threats from US President Donald Trump?"

The MPCC chief said the rally was organised to honour the bravery of Indian armed forces during Operation Sindoor. It was also to pay tributes to the martyrs of the India-Pakistan wars, the war with China, the Kargil war, the 1948 war, as well as to former prime ministers Indira Gand hi, Rajiv Gandhi, Mahatma Gandhi and the tourists who were killed in Pahalgam, he said.

Talking about Union Home Min ister Amit Shah's three-day visit to Maharashtra with a rally in Nanded, Sapkal alleged that he (Shah) did not speak about promises made during election campaigning—such as farm loan waivers, Rs 2,100 for dear sisters or two free domestic gas cylinders.


