A&N to assess ecological impact of rising tourism

Domestic tourism has surged since pre-COVID.

NEW DELHI: The Andaman and Nicobar government is analysing the impact of opening new islands and the rising influx of tourists in the archipelago to ensure the preservation of the ecosystem while ensuring more islands are opened in a graded manner, officials said.

The island Union Territory known for its pristine beaches and mangrove kayaking tours, has witnessed a significant jump in domestic tourism since pre-COVID years.

"We had a very successful tourist season last year. We were able to overcome the effects of COVID-19, and last year, on an island with a population of 4 lakh, we welcomed 7.2 lakh visitors. This year, we are experiencing substantial growth as well. We have already recorded 6 lakh visitors by September, and our

TEZPUR: Top ULFA(I) insurgent Arunodoi Asom, who surrendered before security forces, will be kept in Assam, Chief Minister Himanta Biswa Sarma said on Sunday.

He said the militant will be kept in custody in Tinsukia in Upper Assam.

The circumstances and other details of the surrender of Arunodoi Asom, also known as Arunodoi Donotia, and his bodyguard have not yet been shared by officials.

Asked about Dohotia's surrender on the sidelines of a programme at Rangapara in Sonitpur district, Sarma said, "As far as I know, they won't be taken to Delhi. They will remain in Tinsukia. At the most, they will be taken to Guwahati to meet the DGP."

"The Assam government does not have any plan to take them to Delhi," he added.

On peace negotiations with ULFA(I), the chief minister said it can progress only if the proscribed outfit's chief Paresh Baruah comes iorwara.

"Talks can happen only with Paresh Baruah. There is no point talking with someone else," he added.

The chief minister also did not elaborate on where the surrender took place.

Dohotia, leader of the militant outfit, is among the accused named by the NIA in killing of Assam Police officer Bhaskar Kalita during an operation against the ULFA(I) in 2018.

According to popular Tibetan belief, Dalai Lamas are "reincarnated" after death.

Tsering, however, said the concept of emanation

is unpredictability." Tsering also said that visits like his were part of a larger plan to create awareness about the Tibetan issue and "challenge China's distortion of facts" even as he accused the neighbouring country of committing "cultural genocide".

"At times I think we are dying a slow death, as the Chinese are striking at the 'core' of our identity," he said, explaining his outreach efforts for awareness.
