Marking the end of an era in Kerala's CPI(M)-led Left movement, communist veteran and former Kerala Chief Minister V.S. Achuthanandan passed away at SUT Hospital here today at

The 102-year-old comrade, often referred to as the 'Fidel Castro of Kerala,' was admitted to the Intensive Care Unit of SUT Hospital following a heart attack on June 23, shortly after returning home from a routine check-up on June 22.

He is survived by his wife K. Vasumathi, son V.A. Årun Kumar, and daughter Dr. V. Asha.

Chief Minister Pinarayi Vijayan, CPI(M) State Secretary M.V. Govindan, ministers, party leaders, and several others visited the hospital before his demise.

Achuthanandan's death marks the end of a chapter in Kerala's Left movement - his life bridging grassroots struggles and state leadership, with unwavering commitment to labour rights and land reform.

His journey from youthful rebel to elder statesman earned him deep re-



spect across political lines.

He served as Chief Minister of Kerala from 2006 to 2011, and later as the Chairman of the Administrative Reforms Commission with cabi-

state Youth Congress president, the protest — called "Writers' Chalo Ab-hiyan" — demanded that voter ID cards be the sole proof for voting to curb purported widespread electoral fraud, referred to as "scientific rigging" by the opposition parties and a section of the modia section of the media.

Addressing the gathering, Banerjee alleged that a "systematic attack" is underway on Bengali identity, with re ports of Bengali-speaking individuals being harassed and even arrested in states like Madhya Pradesh, Odisha,

"Over a thousand people have been jailed just for speaking in Bengali," Banerjee said.
