Madhya Pradesh Becomes First State to Establish Intra-State Air Connectivity

Bhopal: Madhya Pradesh is set to become the first state in India to establish comprehensive intra-state air connectivity. On the occasion of the state's 70th Foundation Day (November 1), Chief Minister Dr. Mohan Yadav will inaugurate the prestigious 'PM Shri Air Tourism Helicopter Service' at Raja Bhoj Airport. The event will be graced by Union Civil Aviation Minister Kinjarapu Ram Mohan Naidu, among other dignitaries.

New Dimension to State Tourism

The launch is poised to give a significant

boost to tourism by offering faster, more convenient travel between prominent destinations. Additional Chief Secretary and MD of the MP Tourism Board, Shiv Shekhar Shukla, highlighted that this unique initiative will open new avenues for adventure, heritage, and spiritual tourism, greatly enhancing the experience for both domestic and international visitors. The service will be operated by the MP Tourism Board under a Public-Private Partnership (PPP) model.

Three Key Tourist Circuits

Regular helicopter operations, which will commence on November 20, 2025, will run five days a week across three primary sectors, each linking major tourist attractions.

Following the flag-off by CM Dr. Yadav, the initial three helicopters will depart for Ujjain, symbolizing the state's commitment to making travel within Madhya Pradesh faster, more comfortable, and truly memorable.

Bhopal: Leader of Opposition in the Madhya Pradesh Assembly, Umang Singhar, has formally requested the extension of the upcoming winter session of the 16th State Legislative Assembly.

Singhar wrote letters to



Governor Mangubhai Patel, Assembly Speaker Narendra Singh Tomar, and Chief Minister Dr. Mohan Yadav, arguing that the proposed schedule—which includes only four sittings from December 1 to December 5, 2025—is insufficient for discussing critical public issues.

The Leader of Opposition stressed that the state faces numerous important subjects, but the limited duration will prevent comprehensive debate. He urged the leaders to uphold democratic tradition by extending the session's length, ensuring both the opposition and the ruling party have adequate time to discuss matters of public interest in detail.

Singhar stated that the Assembly is the supreme platform of democracy, and the voice of the public must be heard with utmost seriousness. Extending the session, he noted, would strengthen this democratic spirit. The request comes shortly after the Assembly Secretariat issued the notification for the brief four-day winter session.
