The hostel administration has sealed the student's room.

## Govind Goyal elected president of Bhopal Chamber

**Bhopal:** Govind Goyal has won the election for the president of the Bhopal Chamber of Commerce and Industries (BCCI). Out of a total of 1999 votes, Goyal received 1085 votes and Tejkul Pal Singh Pali received 894 votes. Goyal won by a margin of 193 votes. 13 votes were rejected. Goyal was declared the winner after 40 rounds of counting.

The counting was supposed to begin at 8 AM, but the ballot boxes could only be retrieved from the police station three hours later. The ballot boxes had been deposited at the Shyamla Hills police station in the presence of the candidates. Since the voting continued until late in the evening, and the

## Rapido boy rapes minor, abandoned her near a temple

**Indore:** The Raaji Bazaar police in Indore have registered an FIR against a Rapido driver for rape and under POCSO Act, based on a complaint filed by a 17-year-old girl. According to the victim, the accused, a Rapido rider, took her to Pardeshipura on the pretext of getting her cheap clothes. There, he raped her and then dropped her off in the Raaji Bazaar area. The victim later sat near a temple. She used ChatGPT to find the phone numbers for the women's police station and Childline and contacted the police. Ironically, the police station was only 200 meters away from where she was.

According to Additional DCP Rajesh Dandotiya, the 17-year-old girl wanted to buy clothes on Sunday. She booked a Rapido ride using her mobile phone. She told the Rapido driver to drop her off at Rajwada. During the ride, the minor mentioned that she wanted to buy clothes.

The Rapido driver then suggested that she could find cheaper clothes in the Pardeshipura area. He then took the minor to his room and raped her. Around 9 PM, the accused left the minor near the Shani Temple. The minor sat there for a long time.

Instead of calling her family, she used ChatGPT to find helpline numbers. She then contacted the police station.
