EOW launches manhunt for builder Anwar Baig in multi-crore fraud case cused. Authorities have urged citizens who may have

Bhopal: The Economic Offences Wing (EOW) has initiated a city-wide manhunt for prominent city builder Anwar Baig, the owner of Hometech Constructions, on charges of fraud and criminal breach of trust. Baig is accused of swindling multiple individuals out of crores of rupees under the pretext of selling them, flats.

The EOW's investigation revealed that Baig entered into agreements to sell flats in Adnan Complex and other properties. Numerous complainants paid him substantial amounts, yet the builder allegedly failed to register the properties or refund their money. Specific complaints include Khalil Usmani being defrauded of Rs 14 lakh, Umar Rauf of Rs 5 lakh, Syed Iqbal Hasan of Rs 8.10 lakh, Raees

Ali of Rs 13 lakh, and Masroor of Rs 10 lakh for a flat in his wife's name.

In a more sophisticated scheme, Baig is also accused of registering properties in his own name after promising "property for property" exchanges, defrauding five individuals of an additional Rs 50 lakh. The EOW has registered a case under IPC sections 420 and 406 and is conducting raids to apprehend the ac-

Kamal Nath opposes land pooling policy, Congress threatens agitation

Bhopal: Former Madhya Pradesh Chief Minister and Chhindwara MLA, Kamal Nath, has voiced strong opposition to the state's new land pooling policy, implemented by the ruling Bharatiya Janata Party (BJP) government. Taking to the social media platform 'X', Nath demanded an immediate rollback of

the "anti-farmer" policy. The senior Congress leader argued that the new land acquisition law would have an adverse impact on farmers' interests. He highlighted the recent example of the Punjab government, which was forced to withdraw a similar policy on Monday following widespread

Nath accused the BJP of consistently pursuing anti-farmer poli cies, pointing out that the government has failed to deliver on its promises. "Despite electoral promises, farmers are not receiving the Minimum Support Price (MSP) for wheat and paddy," he stated.
