

Rinku Majumdar applies for BJP Ticket for 2026 assembly polls

Kolkata (UNI): Rinku Majumdar, wife of former Kharagpur MLA and senior BJP leader Dilip Ghosh, has applied to the party leadership seeking candidature for the 2026 West Bengal Assembly elections. She has submitted her biodata to the Bharatiya Janata Party as part of the formal process. Reacting to the development, Ghosh

said he saw nothing unusual in his wife's application. "She is an older worker than me. I became an MP and an MLA. She also has the desire to become an MLA," he said. He added that the decision on whether she would get a ticket rested entirely with the party leadership.

Ramesh also took a personal swipe at Prime Minister Narendra Modi, mocking his leadership style and global outreach efforts. Referring to Modi's frequent use of acronyms in speeches and international forums, the Congress leader said the Prime Minister was "busy giving the world gyaan through his acronyms and forcing CEOs to hold his hand to demonstrate their solidarity with him."

He concluded his post with a biting acronym of his own, describing what he termed "MODI

governance" as: "Maximum Optics Damaging India."

The remarks come amid reports of high-level diplomatic interactions between US and Pakistani officials in Washington, which have drawn scrutiny from sections of India's opposition. The April 22 attack in Pahalgam had triggered widespread outrage domestically, with the government vowing strong diplomatic measures to hold perpetrators accountable.

The Congress party has repeatedly questioned the effectiveness of India's foreign policy under the Modi government, especially in relation to cross-border terrorism and regional security.

CEC, EC officials to visit poll-bound TN on Feb 26, 27 to review preparedness

Chennai: With the Assembly elections due in five states, the Election Commission of India (ECI) had already initiated the process of holding the democratic exercise in these states.

The Special Intensification Revision of electoral rolls has been completed and the final electoral would be released by Tamil Nadu Chief Electoral Officer Ms Archana Patnaik on February 23.

Ahead of announcement of the schedule for the elections, a high level ECI delegation headed by Chief Election Commission C Gyanesh Kumar is visiting the poll-bound states to review the preparedness. In line with this, Mr Gnanesh Kumar and top ECI officials would be visiting Tamil Nadu for two days on February 26 and 27.

Prohibitory orders imposed in Bagalkot

Bagalkot: Prohibitory orders were imposed in Bagalkot city, Karnataka, on Friday following tensions triggered by a stone-pelting incident in the city's old town during the Chhatrapati Shivaji Maharaj Jayanti procession.

The tension was reported near Panka Masjid, when stones were hurled as the procession passed in front of the mosque, causing minor injuries to police personnel and raising public concern.

The prohibitory orders have been extended until February 24, with further arrests expected based on CCTV footage, particularly in connection with a related vegetable shop fire case.

Eyewitness Umesh reported that around 8-10 people threw stones and slippers at approximately 10 p.m. "The incident happened suddenly near the mosque. Fortunately, no civilians were injured, but it created panic among the crowd," he said.
