

Gym operator was purchasing drugs from Machhli

Bhopal: A major breakthrough has been made in the investigation into Bhopal's high-profile drug smuggling, rape-blackmail, and land grabbing network. The Crime Branch has revealed that Monis Khan, a prominent gym operator in Bhopal, was purchasing drugs from Shahwar and Yasin Machhli—an uncle-nephew duo deeply involved in the illicit trade. The revelations emerged during the interrogation of Saifuddin, who was the first to be arrested on July 18. Saifuddin disclosed that Monis, a former fitness trainer, was using his gyms in Koh-e-Fiza and Chuna Bhatti to sell drugs disguised as weight-loss supplements to young men and women.

Following Saifuddin's statement, Shahwar and Yasin were arrested on July 21 from separate locations. They

admitted to supplying drugs to Saifuddin and Monis. Based on further leads, police apprehended notorious criminal Anshul Singh alias Bhuri, who sourced MD drugs from a Nigerian national named Ben. Shahwar and Yasin were among his elite clientele. The Crime Branch has now booked Monis as an accused based on Saifuddin's information. However, Monis fled to Malaysia soon after his name surfaced. Authorities are preparing to issue a lookout notice against him.

Additional names such as Umer Patti from Jehangirabad, Vishal alias Sawan from Arera Colony, and Lariib alias Bachcha from Ashoka Garden also surfaced, all linked to drug distribution networks supplied by Saifuddin. Investigations are ongoing.

Bhopal Metro set for commercial launch in Oct

CMRS inspection scheduled for this month



Bhopal: The much-awaited Bhopal Metro is expected to begin commercial operations in October, after flagging off by PM Narendra Modi. Once PM flags off, the metro will be open for public use. In anticipation, authorities are intensifying efforts to complete the remaining work on the Priority Corridor.

The Additional Chief Secretary of the Urban Administration and Housing Department, Sanjay Dubey, along with senior metro officials, recently reviewed the corridor from Subhash Nagar to AIIMS. Dubey directed that any pending work be expedited and also dis-

cussed upcoming inspections with metro officials.

A crucial visit by the Commissioner of Metro Rail Safety (CMRS) is scheduled for September. The CMRS team will carry out two rounds of detailed inspections. Earlier, the Research Design and Standards Organization (RDSO) completed its inspection on August 10 and submitted a positive report on the Priority Corridor.

= CMRS inspection will cover several key areas

The CMRS inspection will cover several key areas including the operation room, electrical section, lifts, escalators, platforms, and other passenger amenities. A trolley inspection of the viaduct will also be conducted, followed by speed and braking system tests on-board the metro.

The metro's performance will be tested at speeds up to 100 kmph, with a focus on passenger safety, vibrations, and emergency braking at 80 kmph. These trials are critical before the metro opens its doors to the public next month.

Specialist unit for thyroid disorders and obesity launched

Bhopal: A dedicated specialist unit for the treatment and research of hypothyroidism and obesity has been inaugurated at the Government Homeopathic Medical College Hospital, Bhopal. The initiative is a joint effort of the Ministry of AYUSH and the Central Council for Research in Homeopathy (CCRH), aimed at offering holistic treatment using homeopathic medicine.

The unit is equipped with a team of specialist doctors, assistant physicians, lab experts, dietitians, and fitness professionals. It will focus on treating thyroid-related disorders and associated obesity through non-chemical, natural therapies. Services will be available daily from 10 AM to 1 PM, with patient inquiries handled from 10 AM to 4 PM via helpline number 0755-299-2972.

Dr S K Mishra, Principal of the college, emphasized that this is the first such unit in Madhya Pradesh, designed to deliver long-term health benefits by enhancing the body's natural immunity. Nodal officer Dr Juhi Gupta highlighted the rising cases among women and the dangers of over-dependence on chemical treatments.
