

'VIP treatment' in jail: Karnataka minister announces probe panel, 2 officers suspended

Bengaluru, November 10

A DAY after multiple videos emerged showing inmates at the Parappana Agrahara Central Prison using cellphones and partying inside the jail, Karnataka Home Minister G Parameshwara Monday announced the formation of a high-level panel to look into the issue and suspended two prison officials for negligence.

Addressing a news conference after a meeting with senior officials, Parameshwara said the panel will be headed by R Hitendra, ADGP, Law and Order. IPS officers Sandeep Patil, Amarnath Reddy, and CB Risyhanth will also be on the panel. The panel will study the conditions of prisons across the state and submit a comprehensive report within a month, he said.

The minister said three of the leaked videos were shot in 2023, while the remaining two were shot three or four months ago. Three officials have been held responsible, Parameshwara said, announcing the immediate transfer of Chief Superintendent of Prison K Suresh, besides the suspension of Superintendent Imamsab Myageri and Assistant Superintendent Ashok Bhajantri. "Based on the findings of the high-power committee report and depending on their involvement, officials will be either dismissed or suspended," he said.

The Home Department will also carry out a technical audit of security apparatus at prisons. Along with it, provision will be made to relay the feed of CCTVs of prisons directly to the offices of senior officials in the Prisons and Correctional Services department, he said. Among the separate undertrials from convicts inside the prison. Noting there were around 5.000 inmates at Parappana Agrahara jail, Parameshwara said separating the two groups would help curb such activities in the future. The announcements came

even as the Opposition BJP

staged a protest against the state government Monday, accusing it of offering "royal treatment" to "terrorists and rapists" inside the prison. LoP R Ashok and BJP state president B Y Vijayendra were detained as they marched towards the Chief Minister Siddaramaiah's house demanding his resignation. Asking the CM to step down immediately, Ashok accused the Congress government of "appeasing terrorists". "The prison has turned into a haven for terrorists. They are availing facilities better than in a five-star hotel," he said. Viiavendra alleged terror convicts enjoyed amenities in jail as Congress encouraged radical el ements. "Without support from the government, such an inci dent would not have happened.'

The videos showed high-se curity inmates freely using smartphones inside the jail. At least six videos showed prisoners using smartphones watching television, and moving freely within the premises A clip shows serial rapist and killer Umesh Reddy sitting be side a TV in his cell and talking on a smartphone, while another captures Juhad Hameed Shakeel Manna, accused of recruit ing for the terror group ISIS using a smartphone.
