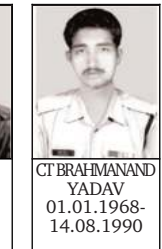

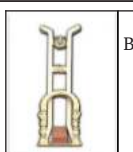

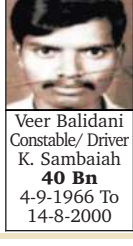
On the 14th of August 2012, troops of 210 CoBRA Bn launched an operation against Maoists in the jungles of Pisepara, PS-Basaga, district Bijapur. When the troops were combating the jungle, the scout Constable S. Prabhu noticed some movement in the dense jungle. He immediately alerted his troops and advanced ahead tactically. The Maoists had taken positions behind secured covers and on noticing the advance of troops opened fire at them. The troops also retaliated bravely and a fierce gunfight ensued. Constable S. Prabhu, who was at front, advanced daringly towards the enemy position and with his accurate fire injured a few Maoists. But in the endeavour he himself got hit and attained martyrdom. His sheer observation and daredevil attitude saved the day for CRPF as Maoists had laid a well-planned ambush at the place to inflict heavy casualties on Security Forces. For his bravery and gallant act, he was awarded the Police Medal for Gallantry posthumously by the Honourable President of India.



Veer Balidani Constable Naresh Mishra

3-2-1937 To 14-8-1965

During August 1965, 6 Bn was deployed along the Line of Control in Poonch district of Jammu and Kashmir. Enemy troops launched a fierce attack on CRPF post of 6 Bn located at Gilli. Troops fought valiantly and repulsed the attack. During the fight bunkered by Constable Naresh Mishra was completely damaged by a rocket. Despite the setback Constable Naresh Mishra continued to engage the enemy firing heavily till his last breath. For his act of conspicuous gallantry and indomitable valour he was awarded President's Police and Fire Services Medal for Gallantry posthumously.

On 10th August 2000 a party of 40 Bn CRPF went for bank encasement duty. Constable/ Driver K. Sambaiah was at the gate of SBI Main branch, Residency Road, Srinagar when a small blast took place. More forces reached the spot and were inspecting the site when an IED hidden in a private car exploded engulfing the area with fire. Constable/ Driver K. Sambaiah sustained burn injuries and was evacuated to Safdarjung Hospital, Delhi where he succumbed to his injuries on 14th August and attained martyrdom.
