EC delists 474 registered unrecognised parties over poll no-show

THE ELECTION Commission (EC) on Friday said it has de-listed 474 more registered unrecognised political parties for flouting

pointical parties for flouting norms, including not contesting elections in the last six years. In the first phase of the exer-cise, the EC de-listed 334 regis-tered unrecognised political par-ties (RUPPs) on August 9.

Ties (KUPP'S) on August 9.
"In continuation, in the second phase, ECI delisted 474 RUPPs on September 18, based on non-contestation in elections onducted by ECI continu conducted by ECI continuously for fyears. Thus SOR RUPPs have been delisted in the last 2 months, 'the poll body said in a statement. The guidelines for the registration of political parties note that if a party does not con-test elections continuously for six years, it will be taken off the list of registered parties. Till recently, there were 2,520 RUPPs. After the el-listing exer-cise, 2,046 RUPPs remain. Besides, there are six recep-

Besides, there are six recog-nised national parties and 67

state parties.
Of the 808 RUPPs de-listed in the last two months, 14 are from Bihar, where Assembly polls are due in November.

Separately, 359 RUPPs have been identified for not having submitted their annual audited accounts in the last three financial years -- 2021-22, 2022-23 and 2023-24 -- within the stipulated times and the second and constraints. lated time period and contesting polls but not filing election ex-penditure reports. These parties are from 23 states and Union ter-ritories. Since 2001, the EC has

ritories. Since 2001, the EC has carried out the exercise of weed-ing out defunct RUPPs 'three to four' times, officials said. The Supreme Court had ear-lier barred the poll panel from 'derecognising' political parties, noting that it was not prescribed under law, However, the EC has found a way to 'delist parties'. The parties de-listed can be listed again by the poll authority with-out getting into the process of giving them fresh recognition, a for-mer EC functionary pointed out.

are registered with the EC under the provisions of section 29A of the Representation of the People Act, 1951. Under the provision, any association once registered any association once registered as a political party gets certain privileges and advantages, such as tax exemptions.
