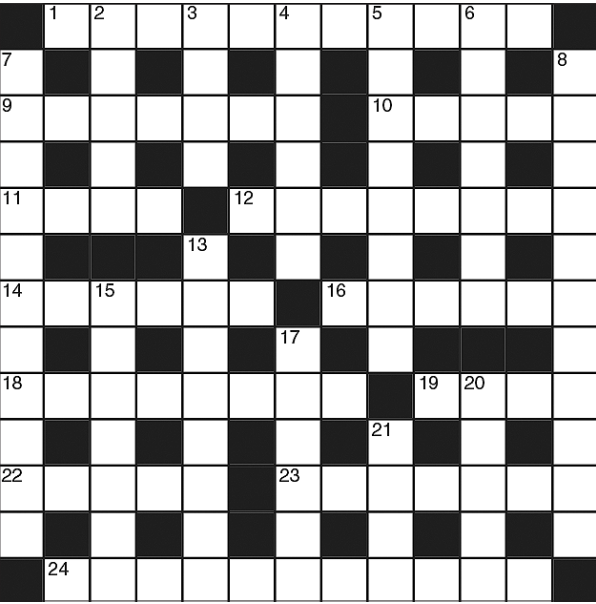

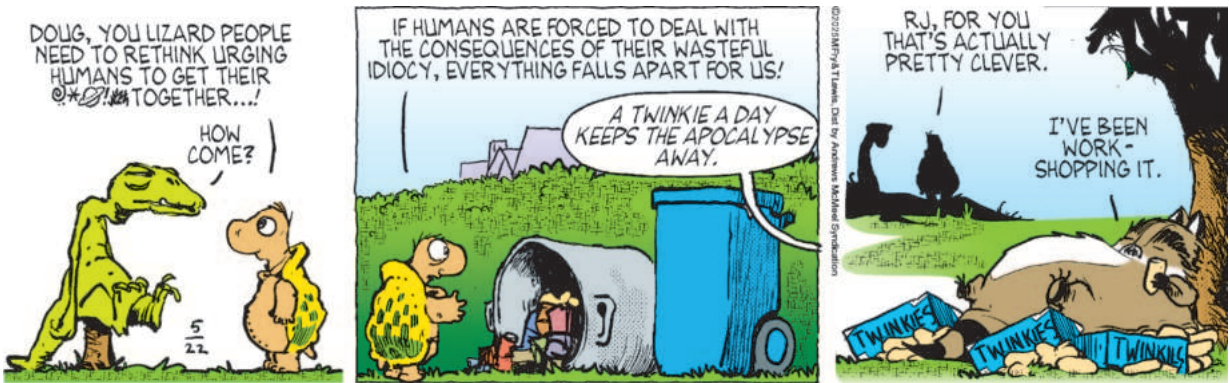

On this day in 1994, on receiving specific intelligence that 10 - 12 foreign trained mercenaries were hiding in a village in Baramula, J&K, he led his Quick Reaction Team in an operation to eliminate them. As they approached, the QRT came under heavy automatic fire. Lt Col Gaur, using cover, moved forward from a flank and surprised the mercenaries. In the ensuing fight, he killed three of them. Next, he saw a UMG firing from behind some rocks. Unmindful of his own safety, he destroyed the position with grenades, killing more mercenaries and neutralising the fire which would have inflicted casualties on his troops. During this courageous act he was mortally wounded, but refused to be evacuated till success was achieved. His courageous actions inspired his troops, who eliminated the remaining terrorists. We, the fraternity of the Bihar Regiment, salute you.
