## State budget for FY 2025-26 reflects the priorities and aspirations of Haryanvis: CM

Haryana Chief Minister, Sh. Nayab Singh Saini while addressing a press conference held on monday said that the state budget for the financial year 2025-26 is a reflection of the priorities and aspirations of the people of Haryana. To fulfill these aspirations, the budget includes a commitment to complete 90 of the Sankalp Patra's promises within this year. So far, the government has fulfilled 19 of the 217 commitments in the Sankalp Patra, and work is ongoing on 14 oth-

Cabinet Ministers, Sh. Krishan Lal Panwar, Sh. Vipul Goel, and Sh. Krishan Kumar Bedi also remained present during the press conference.

The Chief Minister, while making a mention of the 'Sankalps' made in the budget 2025-26, said that to make Haryana 'future-ready', a new department called 'Department of Future' will be created. Additionally, the Haryana AI Mission will be established, and AI hubs will be set up in Guru-

The Chief Minister said that under the 'Mhara Gaon Jagmag Gaon scheme', 5,877 villages are already receiving 24-hour electricity. A new scheme will be launched for the remaining 1,376 villages Besides this, under the PM Surya Ghar: Muft Bijli Yojana, the target is to install 2.22 lakh solar rooftops by March 31, 2027. So far, 15,000 homes have been fitted with 2 kW so-

lar rooftops.

## Cow dung and cow urine will become medium to save ancient culture and health

Efforts are being made from Karnal to save the cow breed and make the cow herders self-reliant. Now idols of God, Vandanvar, Pooja garlands, incense sticks, Shiv's form along with other art works will be made from cow dung. Cow product manufacturing campaign is being started under Gau Utpad Swavalambi Project with the inspiration of Gau Mayi Swavalambi Yatra in Seva Bharti campus of Karnal. Under this, a fifteen-day training programe for women is going on from March 9. Trainers have come from Nagpur in

Maharashtra to train selected women of the state. This training is being led by Tarun Jain from Jagadhri. Materials of daily use are being made from cow dung and urine. These women will go all over the state and train women. Not only cow milk, curd and ghee will be used, but cow dung and urine will also become a means of livelihood for people. The main objective behind this is to save the cow breed. This training programme is being conducted under the supervision of Surendra Groyal of Seva Bharti. Sachin and Ashish from Maharashtra said that they started this campaign in the tribal areas of Nagpur and Vidarbha.
Through this, the tribals were to be

made economically strong. At the same time, they were to be saved from the vicious circle of Christian missionaries and brought closer to Sanatan culture by connecting them with cow conservation. Now they have given training in various parts of the country including Delhi, Punjab, Madhya Pradesh, Uttar Pradesh, Maharashtra, Rajasthan, Punjab. He said that for this, the dung of those cows is used which are not tied and neither are they given chemicals. Through this campaign, ru-



ral women will be made financially self-reliant. Training will be given to make these products: He told that during the training, 12 types of cow urine extract (for different diseases), 9 types of Ghanvati (for different diseases), Pittashamak Churna, Black Toothpaste, Plain Toothpaste, Phenyl from cow urine, Designer camphor sticks from cow dung.

Asha workers should be given a minimum salary of Rs 26000, Asha workers should be made permanent, ESI and PF should be deducted, Asha workers should be given a compensation of Rs 5 lakh on death, Rs 2 lakh be given on retirement
