

BJP Protests in Zirakpur Over Remarks on Sikh Gurus

ZIRAKPUR: The Bharatiya Janata Party (BJP) on Tuesday staged a strong protest in Zirakpur against Aam Aadmi Party (AAP) leader Atishi Marlena, alleging that her remarks regarding the Sikh Gurus were objectionable and hurt the religious sentiments of the Sikh community. During the protest, BJP leaders and workers burnt the effigy of Atishi Marlena and raised slogans against the Aam Aadmi Party, expressing their anger and demanding accountability over the issue. The protest was led by senior BJP leaders, including Iqbal Singh Lalpura, former Chairman of the National Commission for Minorities, BJP Punjab State Secretary Sanjeev Khanna and District BJP President Sanjeev Vashisht. Addressing the gathering, BJP leaders stated that any attempt to hurt the religious faith of the Sikh community or undermine the dignity of the Sikh Gurus would not be tolerated under any circumstances. Speaking jointly, Sanjeev Khanna and Sanjeev Vashisht alleged that AAP leaders remember Punjab's Gurus and saints only during elections, but later resort to derogatory language once their political objectives are achieved. They asserted that any statement hurting the faith and sentiments of the Sikh community would be strongly opposed. The BJP leaders further demanded that the Speaker of the Delhi Legislative Assembly should ensure that Atishi Marlena is not allowed to enter the Assembly until she issues a public apology for her alleged remarks concerning the Sikh Gurus. Former Minority Commission Chairman Iqbal Singh Lalpura termed the language allegedly used by AAP leaders against the Sikh Gurus as highly condemnable. He stated that the issue is not limited to the BJP alone and that no resident of Punjab would tolerate any form of disrespect towards the Sikh Gurus. He warned that the BJP's agitation would continue until a public apology is tendered by Atishi Marlena.
