SDM Anubhav Mehta said that the Election Commission of India aims to make the voter list more transparent, accurate, and error-free, for which the special intensive review process of the voter list must be carried out seriously. This scheme has been implemented nationwide by the Election Commission of India. The work is now underway across the state. SDM Anubhav Mehta chaired a meeting of supervisors at the PWD Rest House Ladwa on Monday. 217 polling stations have been set up in the Ladwa assembly constituency. 22 supervisors have been appointed at these centers. Each supervisor has been assigned 9 to 10 polling stations. In the meeting,

SDM Anubhav Mehta also sought suggestions from the supervisors on the challenges faced in implementing this process, technical assistance, and public awareness campaigns. Anubhav Mehta said that the special intensive review process of the voter list aims to identify duplicate voters, remove the names of deceased voters, and include new eligible voters. It also aims to make the voter list transparent. Through this process, duplicate voters are to be identified and removed, and the names of deceased or relocated voters are to be removed from the draft voter list. Along with this, the registration of new voters is also to be made easier and faster, so that the voter list can be purified and made transparent well in advance of the upcoming elections.

Rihod-Barwala Bridge to be inspected in 10 days, DC reviews flood relief works

BARWALA: Deputy Commissioner Satpal Sharma visited various rivers and vulnerable areas with officials from concerned departments to review flood relief works in district. During visit, he instructed all concerned officials to prepare estimates and detailed reports for flood relief works on a priority basis and submit them promptly. Taking serious note of the condition of Rihod-Barwala bridge, Deputy Commissioner

ordered a joint team of HSV and Public Works Department (PWD) to inspect bridge in 10 days and submit a report on its actual condition, so that traffic on bridge can be restored as soon as possible. DC reviewed erosion in Surajpur river and condition of embankments there. Remaining portion of river was measured on spot. He instructed Executive Engineer Deepak Kumar of Irrigation Department to prepare an estimate of projected cost and submit report.

DC reviews NIPUN Haryana mission, directs schools to ensure 100% Class 10 and 12 results

She emphasized that educated citizens are the foundation of a strong nation and said that the progress of students would be reviewed again in an upcoming follow-up meeting. Healing on Wheels: Free medical van brings vital care to Chhajjupur and Tikri residents

CM Dhami speaks to father of deceased Tripura man, assures strict punishment to accused

DEHRADUN: Amidst the outrage over the murder of a Tripura student in Dehradun, Uttarakhand Chief Minister Pushkar Singh Dhami spoke to his father on phone on Monday and assured him of strict punishment for the accused, officials said. Dhami, in a phone conversation with Angel Chakma's father Tarun Prasad Chakma, expressed grief over murder of his son and said he is personally saddened by the incident and can understand the pain of his family, they said. The chief minister said that children from India and abroad come to Uttarakhand to study, and such an environment has never existed here before. He said, "Therefore, this incident is sad for all of us also." Dhami said that the government will take strict action in this matter. He told Tarun Prasad Chakma that five accused have been arrested in connection with the incident, while another accused is suspected to have fled to Nepal, and efforts are being made to arrest him by declaring a reward. The chief minister also said that he has spoken to Tripura Chief Minister Dr Manik Saha as well as Union Home Minister Amit Shah and Defence Minister Rajnath Singh regarding the incident. Dhami stressed that the state government completely stands with the victim's family. Assuring all possible assistance from the Uttarakhand government, Dhami said he will talk to Dr Saha to help the family. Angel Chakma, a 24-year-old final year MBA student at a private university here, was seriously injured when he was allegedly attacked by some youngsters with a knife and a bracelet on December 9. He died on December 26, after being hospitalized for 17 days.
