**To the Board of Directors of Aavas Financiers Limited**

1. We have reviewed the accompanying statement of unaudited financial results ('the Statement') of **Aavas Financiers Limited** ('the NBFC') for the quarter ended **30 June 2024**, being submitted by the NBFC pursuant to the requirements of Regulation 33 and Regulation 52 read with Regulation 63 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) ('Listing Regulations').
2.
