This is in continuation to our letter bearing reference no. AAVAS/SEC/2024-25/501 dated August 10, 2024 *inter alia* informing about: (i) the execution of the share sale agreements amongst Aquilo House Pte. Ltd. ("**Purchaser**"), Aavas Financiers Limited ("**Company**") and certain members of the promoter and promoter group of the Company, pursuant to which the Purchaser has agreed to acquire in aggregate 2,09,49,112 equity shares of the Company constituting 26.47% of the paid-up share capital of the Company from the said members of the promoter and promoter group of the Company; and (ii) the obligation of the Purchaser to make an open offer in accordance with the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (together, "**Proposed Transaction**").

In this regard, we would like to inform that the Competition Commission of India ("**CCI**"), vide its letter dated October 22, 2024, has communicated that the CCI, in its meeting dated October 22, 2024, has considered and approved the Proposed Transaction.
